## Program Application Form

- e. He/She applies for a Permanent Residence Permit and Bulgarian Identity Card

### APPENDIX

#### GROUND FOR REFUSAL

The Bulgarian Government has the right to refuse Visa D issuance and permanent status of an applicant who is prepared to invest in the Bulgarian Investment Immigration Program, on the following basis. The candidate is required to review the following section, initial pages and sign/date the last page. Please contact Prinz von Preussen for any reason the candidate is not clear about the text, and/or is not clear about his or her situation regarding any point listed herein.

#### VISA “D” MAY BE REFUSED FOR THE FOLLOWING REASONS:

1. With his acts, the Applicant has jeopardized or may jeopardize the interests of the Bulgarian State, or if there is reason to believe that the Applicant acts against national security;
2. the Applicant has, with his/her actions, discredited the Bulgarian state or has derogated from the prestige and dignity of the Bulgarian nation;
3. there is a reason to believe that the Applicant is member of a criminal group or organization, or that he/she engages in terrorist activities, smuggling and illicit transactions in arms, explosives, ammunition, strategic raw materials, dual-use items and technologies, as well as in illicit trafficking in narcotic drugs and psychotropic substances and precursors, and in raw materials for the manufacture thereof;
4. there is information that the Applicant has been engaged in human traffic, as well as in bringing persons illegally into Bulgaria and taking persons out into other countries;
5. the Applicant was expelled from the Republic of Bulgaria no less than 10 (ten) years before the date of visa application and failed to recover within 6 (six) months as of the expulsion the expenses incurred by the state for his expulsion;
6. the Applicant has committed deliberate crime within the territory of the Republic of Bulgaria punishable under the laws of Bulgaria by more than 3 (three) years of imprisonment;
7. the Applicant has attempted to enter or transit Bulgaria using false or forged documents, visa or residence permit;
8. the Applicant might be presumed to spread an acute communicable disease; or is afflicted with a disease which according to the criteria of the Ministry of Health or of the World Health Organization poses a threat to public health; or is not in possession of a vaccination certificate; or is coming from an area with a complicated epidemic or epizootic situation;



9. the Applicant does not have secure means of sustenance and all the mandatory insurance policies required for the time of stay in Bulgaria, as well as adequate funds to ensure his return;
10. the Applicant has, during previous entries and stays, systematically violated the border-crossing, passport and visa, currency customs regulations of the Republic of Bulgaria;
11. the Applicant has, during a previous stay, breached Bulgarian labor or tax laws;
12. the Applicant is not in possession of visas or tickets for the countries next on his itinerary;
13. a coercive administrative measure has been imposed on the Applicant preventing him/her from entering Bulgaria and such measure is still in effect;
14. the Applicant has been included in the data base of foreigners unacceptable to Bulgaria maintained by the Ministry of Interior and by the Ministry of Foreign Affairs;
15. the Applicant is applying for an entry visa with a document certifying final exit from the territory of another country where he/she has resided until this moment;
16. the Applicant is applying for a visa with an invalid foreign travel document or a substituting document.

#### **APPENDIX (continued)**

#### **PERMANENT RESIDENCY PERMIT MAY BE REFUSED WHEN:**

1. There is information that the Applicant wishes to enter Bulgaria in order to commit a crime or a violation of the public order;
2. the Applicant has, during a previous stay in Bulgaria, committed a violation of the public order;
3. the entry of the Applicant into Bulgaria may prejudice the relations of the Republic of Bulgaria with another state;
4. there is information that the purpose of the Applicant's entry is to stay in Bulgaria as an immigrant without having a special permission;
5. there is information that the purpose of the Applicant's entry is to use Bulgaria as a transit point for subsequent migration to a third country.
6. during a previous stay in Bulgaria, the Applicant has been the recipient of government social assistance;
7. the Applicant fails to provide reasonable grounds for the declared purpose of travel.
8. there is a court injunction in effect which imposes a fine over the Applicant under the procedure set out in the Foreigners in the Republic of Bulgaria Act if such fine has not been paid.
9. the Applicant has not sufficient resources to ensure his/her subsistence in compliance with the length and the conditions of his/her residence in the Republic of Bulgaria, neither for returning to the state of his/her original residence nor for transiting through the Republic of Bulgaria.
10. the Applicant has presented a document with false contents or has stated untruthful information.

Permanent status of an applicant may be refused on the grounds of the reasons above or on different reasons (not specified explicitly in the Foreigners in the Republic of Bulgaria Act) and remains at the discretion of the immigration department.
